# Preparing for Brexit

The Government is committed to ensuring that the range of advisory supports, tool-kits and financial supports available to help businesses to prepare and navigate their way through Brexit continues to evolve as the potential impacts emerge.

The continued increase in business preparedness is welcome, with many businesses taking the first important steps of gathering information, developing Brexit Contingency Plans and working closely with their suppliers on Brexit preparedness.

We know the UK's decision to leave the EU from March 2019 will entail changes to our trading arrangements and supply and distribution chains and may entail new regulatory and other compliance requirements for importers and exporters doing business with the UK; issues of particular relevance for the retail and wholesale sector.
