### What are Hazards?

Hazards are anything with potential to cause harm.

Common hazards in the hardware sector to consider:



Ergonomic

Injuries from manual handling



Workplace Vehicles

- ✓ Pedestrian Segregation
- Deliveries
- ✓ Use of Forklifts



Chemical

- Exposure to chemical substances (Cement,
  - Adhesives)
- Fumes & Dust



Physical

- ✓ Lifting Operations
- Falling items and racking
- ✓ Slips, trips, and falls

### Risk Assessments

The process of identifying what hazards exist, or may appear in the workplace, how they may cause harm and taking steps to minimise them.

## Safety statements and other essential documentation

### **Safety Statement**

A written document that describes how safety, health, and welfare within the workplace is managed and secured.

The key legislative requirements that must be met are:

Written policy on Health & Safety

**Control measures** 

Risk assessment

**Identification of hazards** 

Roles and responsibilities

**Emergency plans** 

**Emergency plans** 

**Review and update** 

Implementation and monitoring

Consultation with employees

**Provision of information & training** 



### **Safety Statement**

Should be created and maintained by a competent person with the necessary knowledge, experience, qualifications, and resources.

#### The policy must contain:

- A H&S Statement: general policy and arrangements
- A structure of individual responsibilities and roles
- A programme of risk assessments including a fire risk assessment
- A programme demonstrating how compliance will be monitored
